

Building on [previous collaborative work](#), The Ohio State University's [Newark Earthworks Center](#) (NEC) partnered with [CHRR at The Ohio State University](#) to conduct a public opinion survey on topics related to Ohio's Earthworks and Native American citizens. Using an Ohio-specific sample from the [American Population Panel](#), researchers gathered information on several issues, including present awareness of and previous visits to the eight Ohio Earthworks sites. Other related issues covered in this survey effort included familiarity with the UNESCO World Heritage designation, the imminent opening of the Octagon, and the second Major Lunar Standstill of the 21st Century.

A total of 1,450 APP panelists participated in this survey, including 1,140 Ohioans and 310 residents of Ohio's border states (Indiana, Kentucky, Michigan, Pennsylvania, and West Virginia). Findings regarding present awareness and previous visits to the Ohio Earthworks sites include:

- 85% of Ohioans and 62% of border state residents have heard of the Ohio Earthworks in Warren County, while 63% of Ohioans and 38% of border state residents previously had visited this site.
- 83% of Ohioans and 64% of border state residents have heard of the Ohio Earthworks in Ross County, while 55% of Ohioans and 35% of border state residents previously had visited this site.
- 78% of Ohioans and 54% of border state residents have heard of the Ohio Earthworks in Licking County, while 44% of Ohioans and 26% of border state residents previously had visited this site.

Answers to additional questions:

Before agreeing to take this survey, how familiar were you with the fact that the Ohio Earthworks recently received the UNESCO World Heritage designation?

Before agreeing to take this survey, how familiar were you with the fact that the Octagon Earthworks location were opened to the general public for the first time in modern history on January 1, 2025?

- NOT AT ALL FAMILIAR Ohioans: 32% Border State Residents: 55%
- SOMEWHAT FAMILIAR Ohioans: 51% Border State Residents: 35%
- VERY FAMILIAR Ohioans: 17% Border State Residents: 10%

Before agreeing to take this survey, how familiar were you with the fact that the second Major Lunar Standstill of the 21st Century is observable at the Newark Earthworks location through 2026?

- NOT AT ALL FAMILIAR Ohioans: 53% Border State Residents: 69%
- SOMEWHAT FAMILIAR Ohioans: 36% Border State Residents: 21%
- VERY FAMILIAR Ohioans: 21% Border State Residents: 10%
